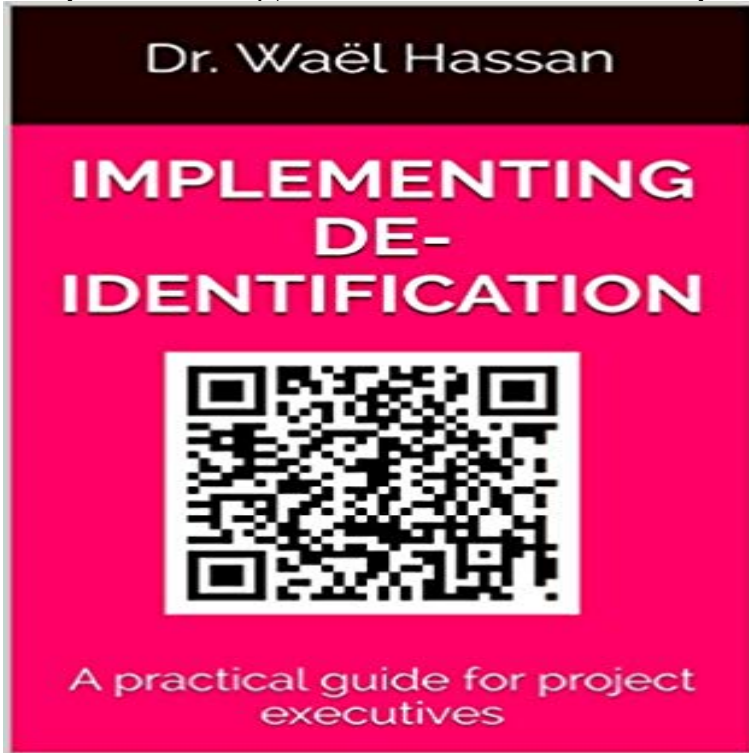


# Implementing De-Identification: A practical guide for project executives
