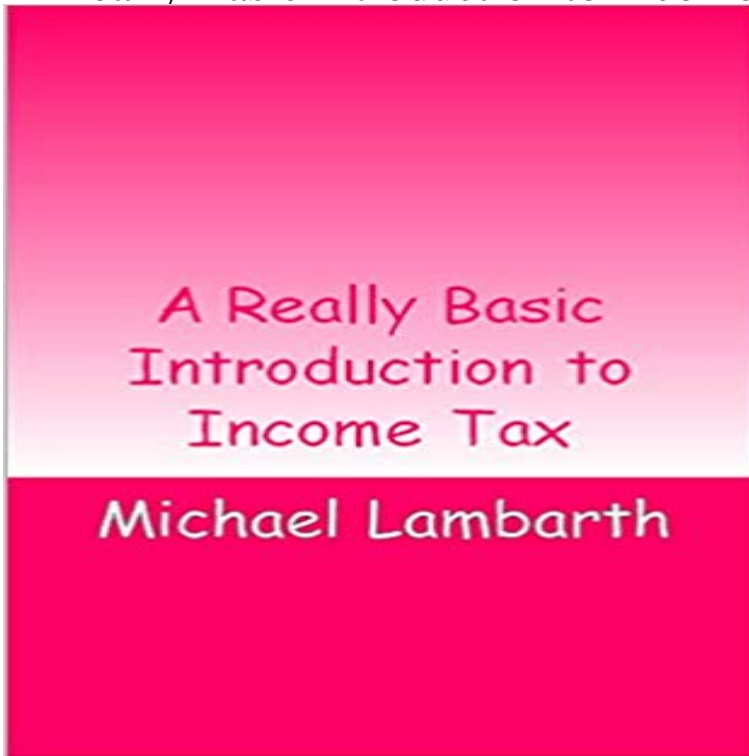


A Really Basic Introduction to Income Tax (Really Basic Introductions)
