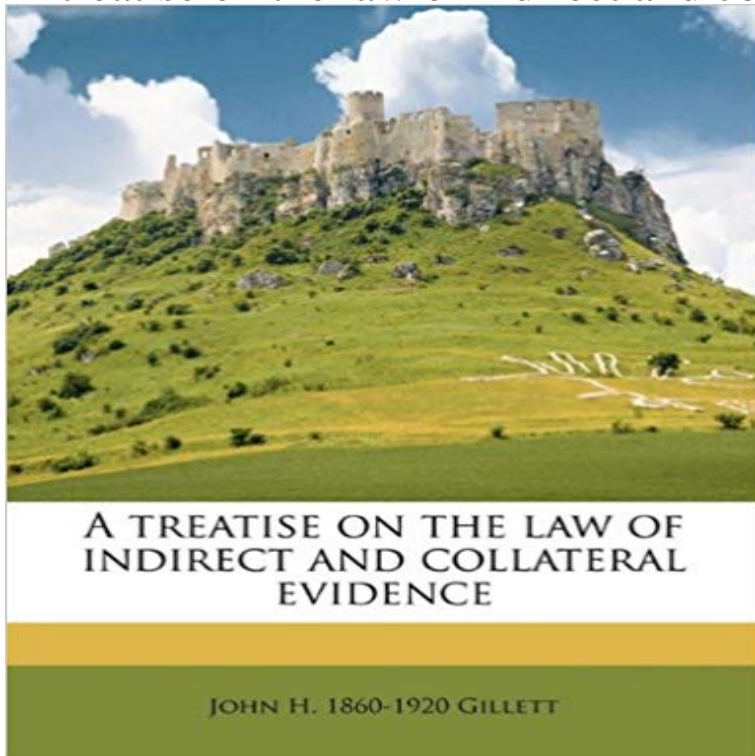


A treatise on the law of indirect and collateral evidence
