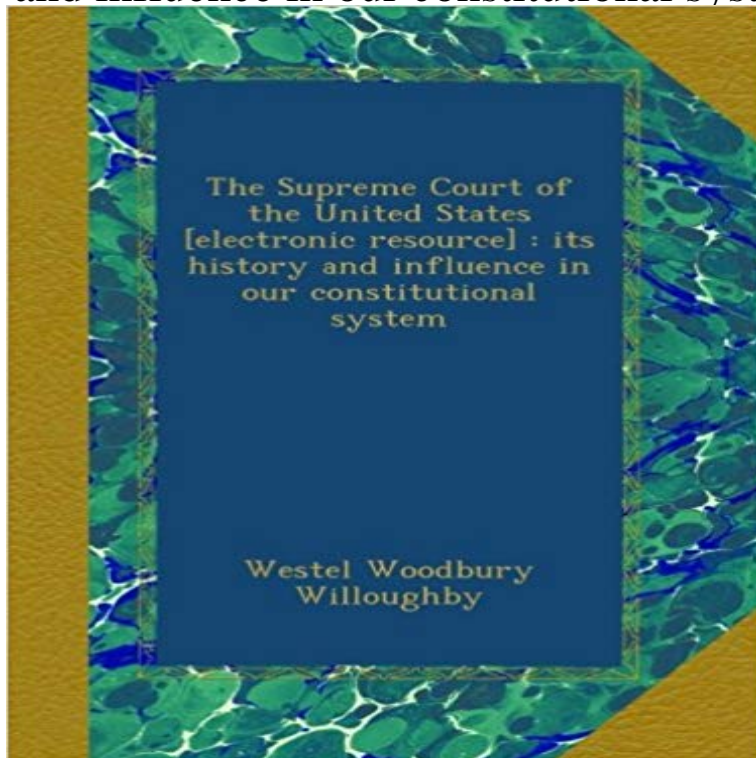


The Supreme Court of the United States [electronic resource] : its history and influence in our constitutional system
