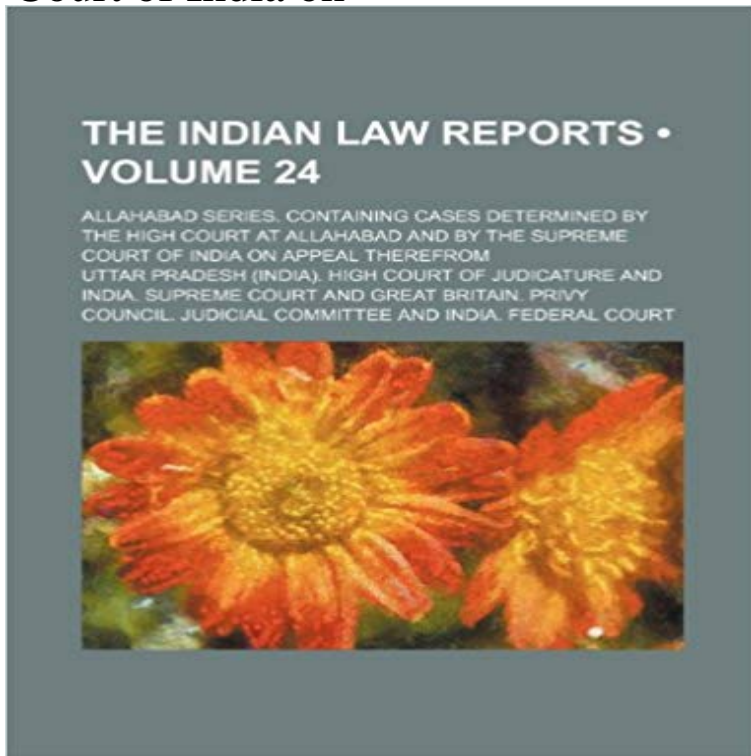

The Court, after recording the evidence of the plaintiffs witness, found that the sum paid for Court fees was insufficient, and by order of the 20th of June, 1886, directed that the deficiency should be made good by the following day. This order was complied with by the plaintiff and the deficiency paid. It was the value which the Court placed upon one of the indigo factories which we shall term the new indigo factory which necessitated the payment of an additional Court fee. The suit was instituted on the 23rd of September, 1897, within the period of limitation, but the payment of the deficiency in stamp duty was made beyond the period of limitation, so that if the latter date is to be taken as the date of the institution of the suit, the claim would be statute-barred according to a ruling of a Full Bench of this Court. When a Court fixes a time under clause (a) or clause (b) of section 54 of the Code of Civil Procedure, it has been held that it must be a time within limitation, and section 54 does not give a Court any power to extend the ordinarily prescribed period of limitation for suits; *Jainti Prasad v. Bachu Singh* (1). This decision has not been followed in the Calcutta High Court in the case of *Moti Sahu v. Chhatri Das* (2). In that case it was held by Prinsep and Banerji, JJ., that the date of the institution of a suit should be reckoned from the date of the presentation of the plaint, and not from the date on which the requisite Court fees are subsequently paid so as to make it admissible as a plaint.
