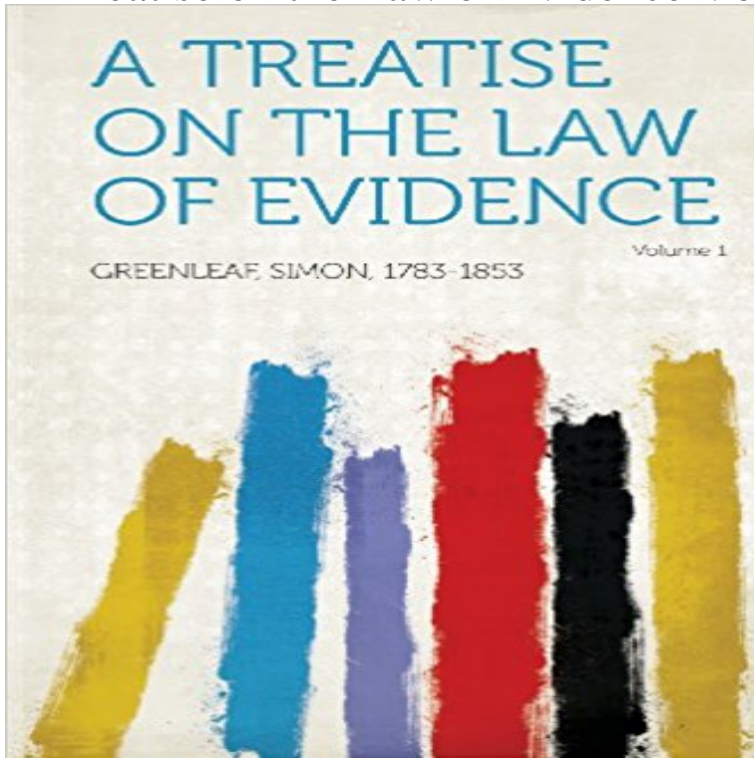


A Treatise on the Law of Evidence Volume 1
