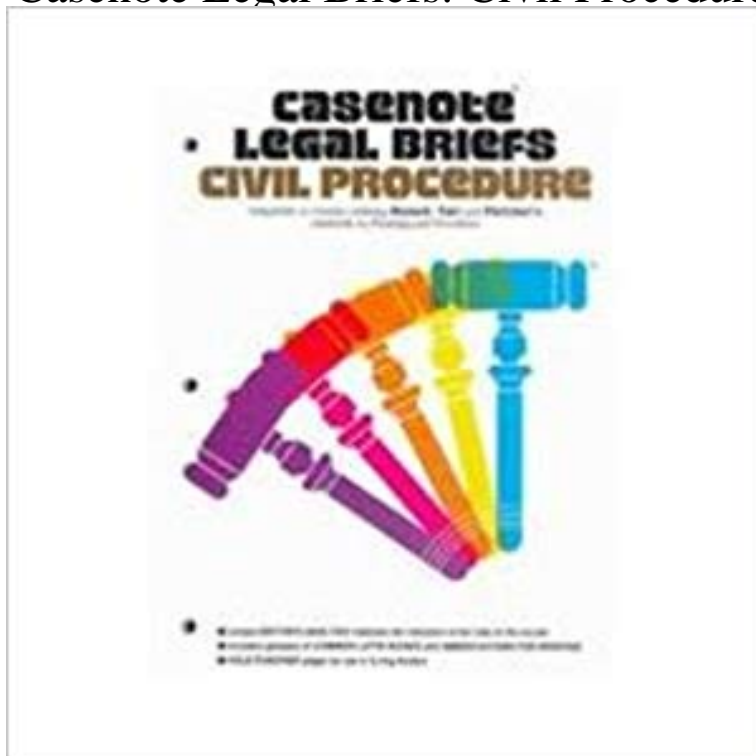


Casenote Legal Briefs: Civil Procedure: Hazard Tait & Fletcher
