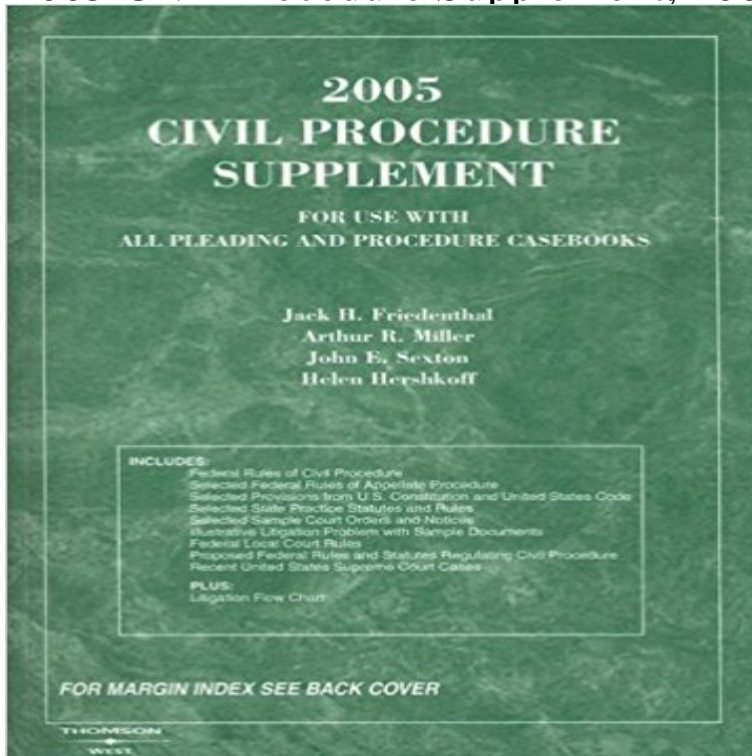


2005 Civil Procedure Supplement, 2005 (American Casebooks)
