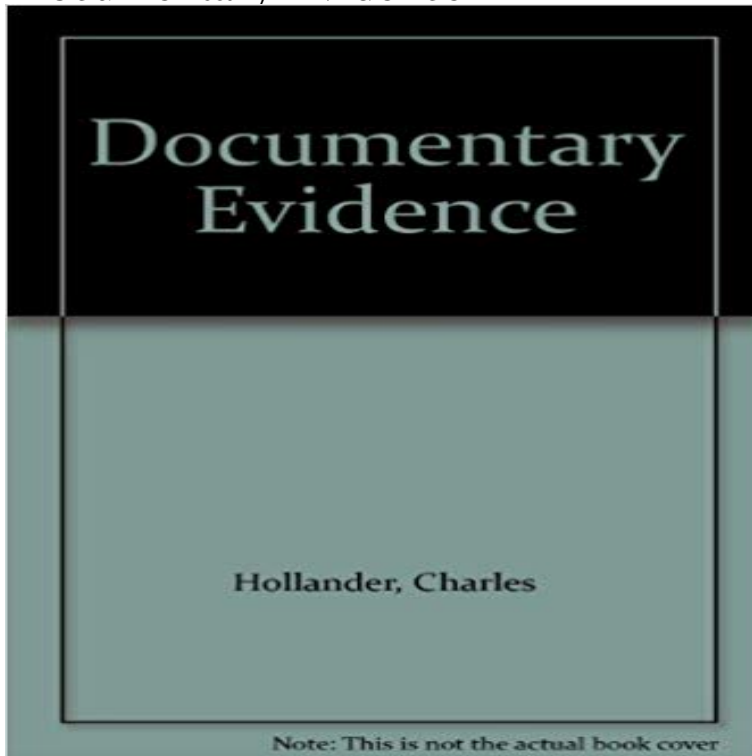


## Documentary Evidence
