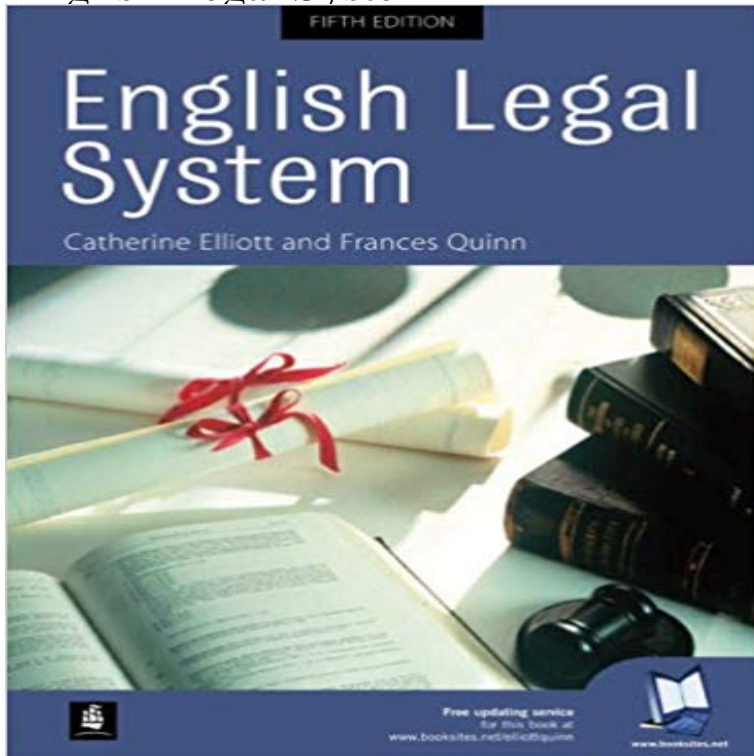


English Legal System
