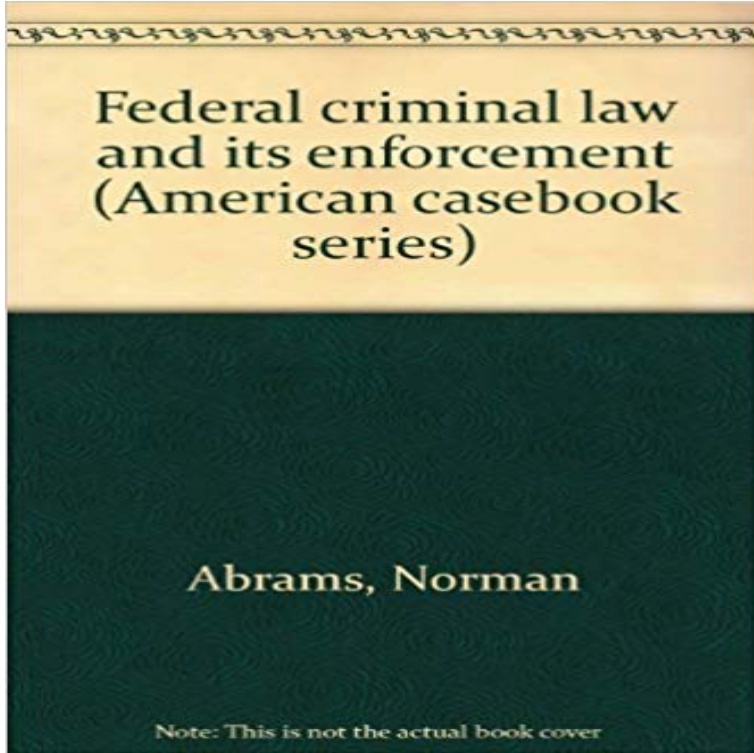


Federal criminal law and its enforcement (American casebook series)
