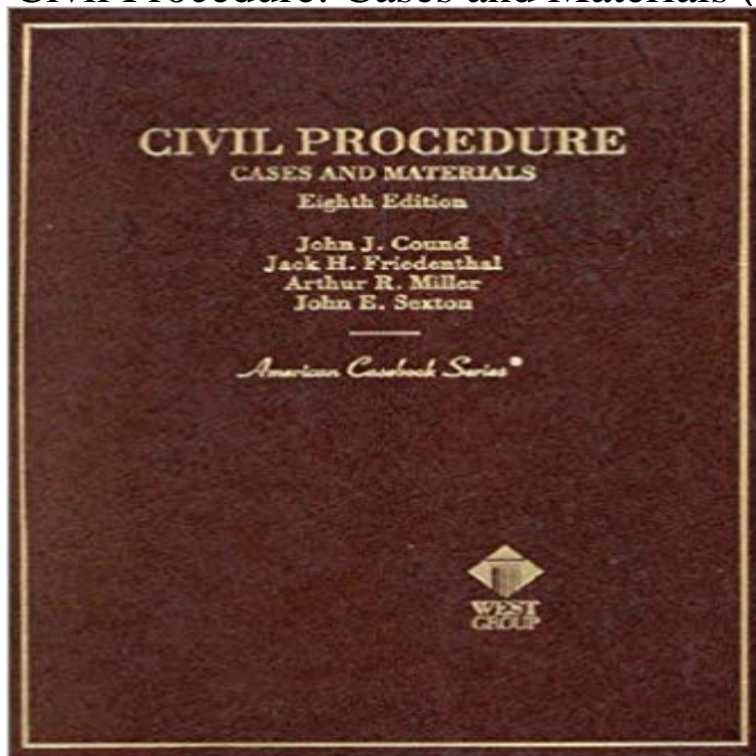


Civil Procedure: Cases and Materials (American Casebook Series)
