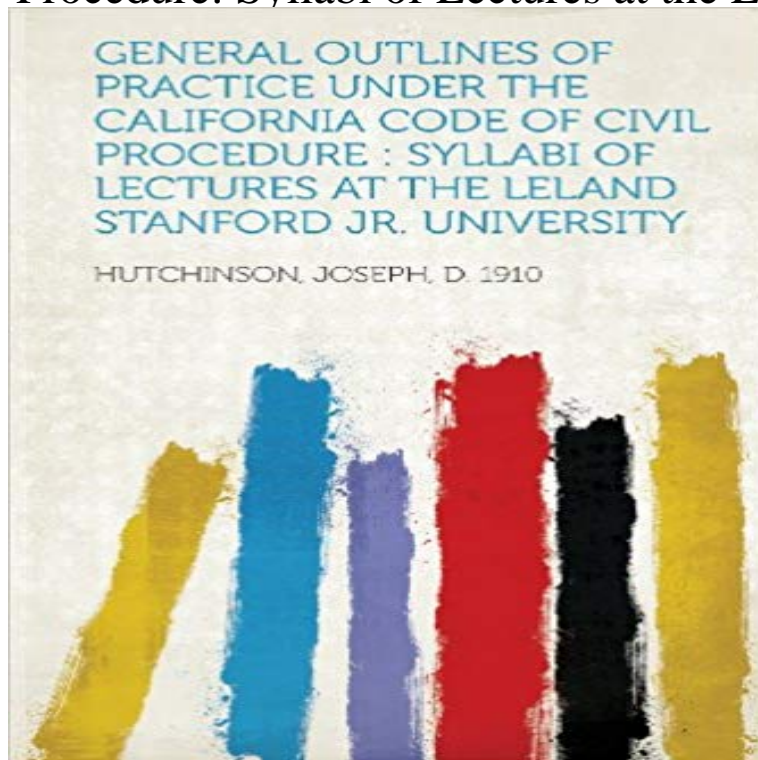


# General Outlines of Practice Under the California Code of Civil Procedure: Syllabi of Lectures at the Leland Stanford Jr. University
