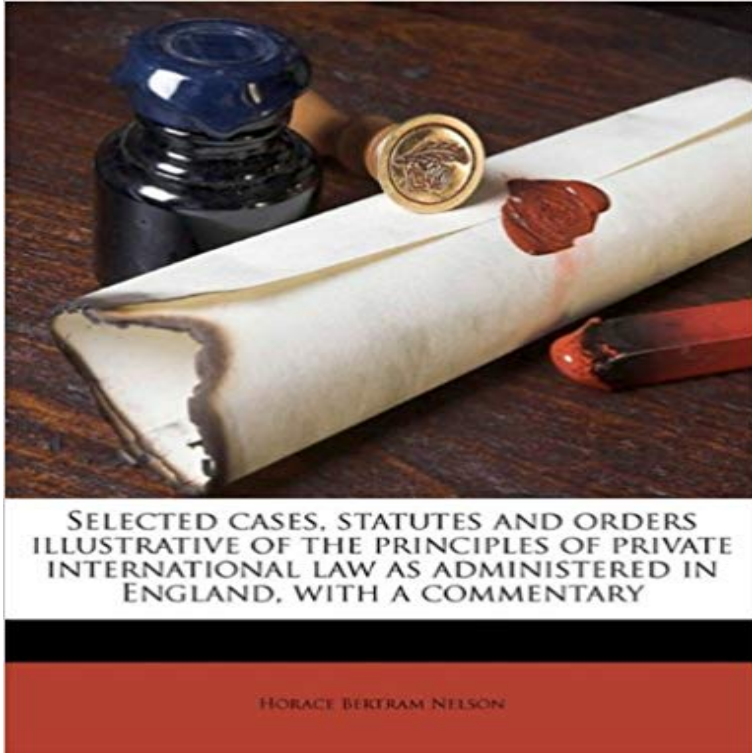


## Selected cases, statutes and orders illustrative of the principles of private international law as administered in England, with a commentary
