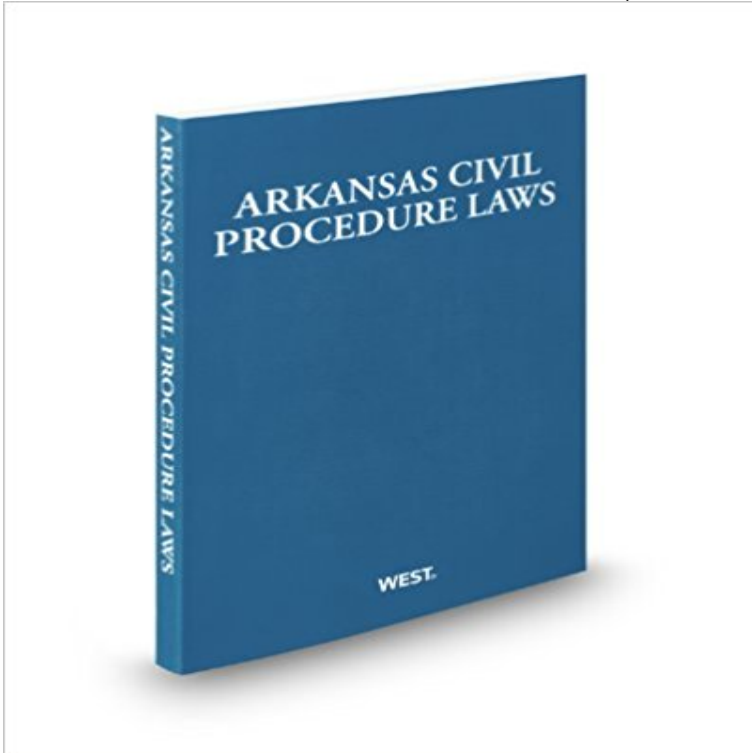


Arkansas Civil Procedure Laws, 2012 ed.
