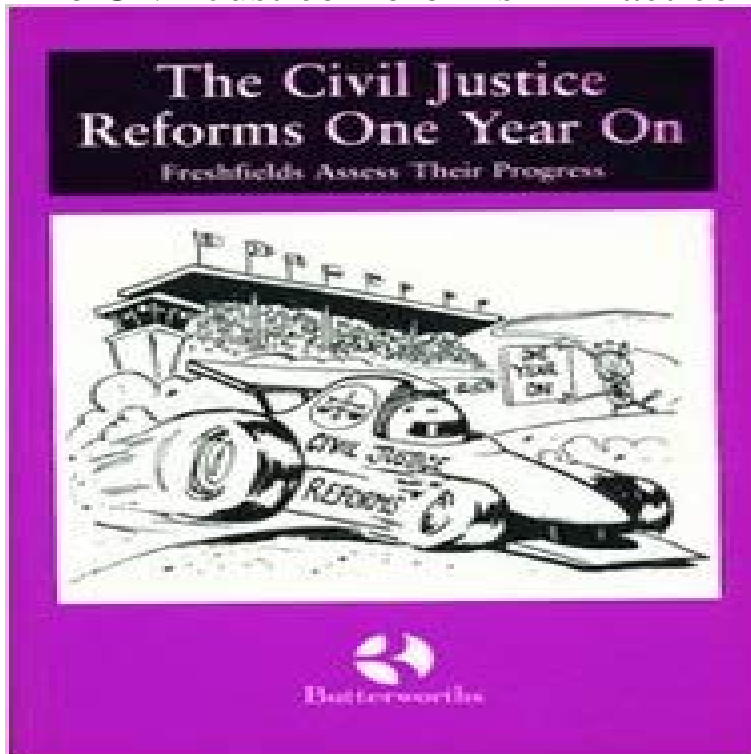


## The Civil Justice Reforms in Practice
