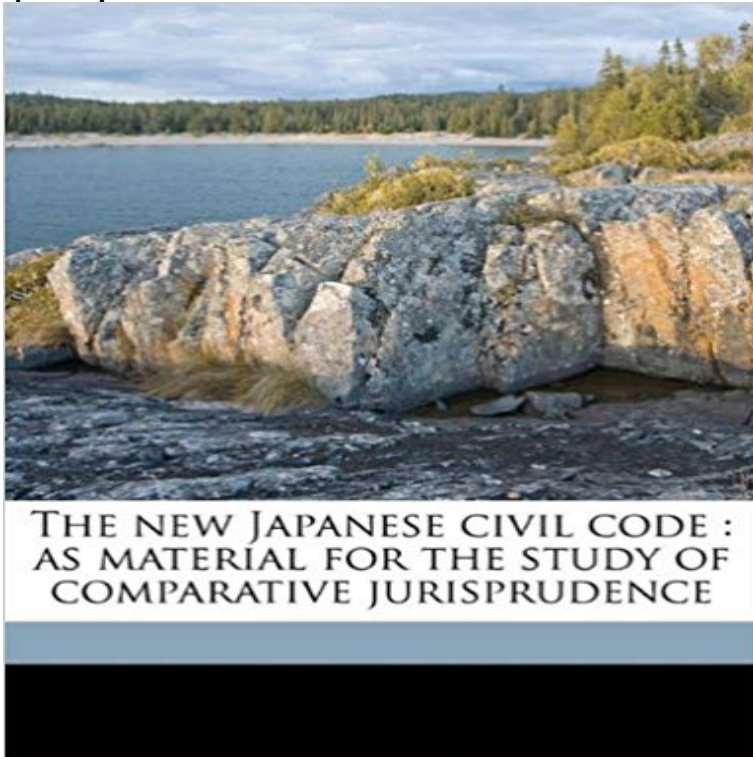


# The new Japanese civil code: as material for the study of comparative jurisprudence
