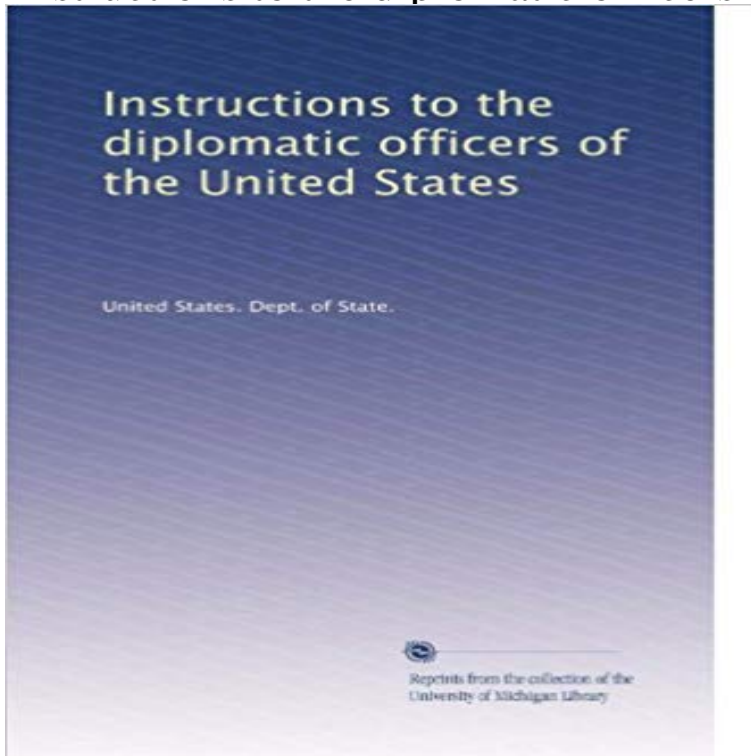


Instructions to the diplomatic officers of the United States
