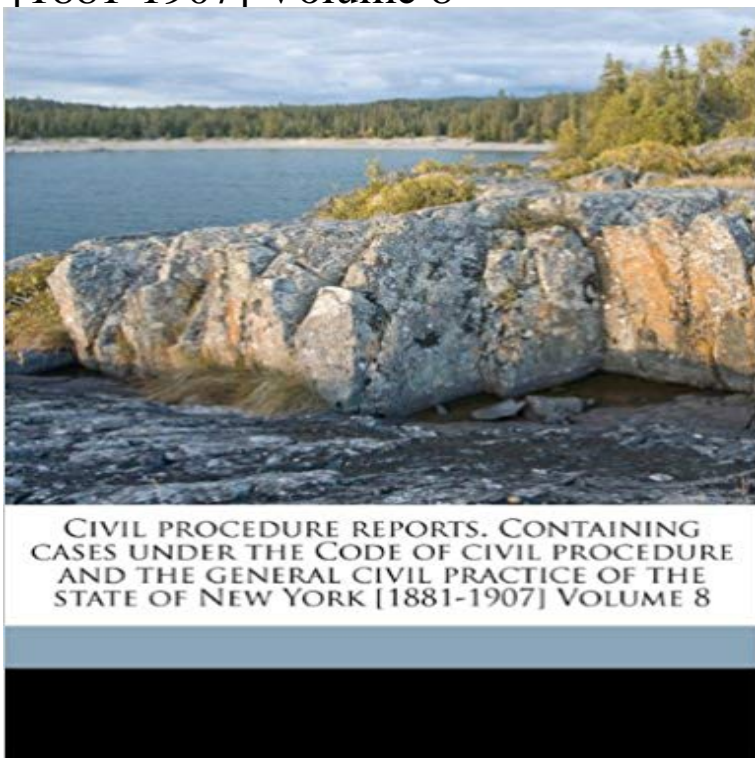


Civil procedure reports. Containing cases under the Code of civil procedure and the general civil practice of the state of New York [1881-1907] Volume 8
