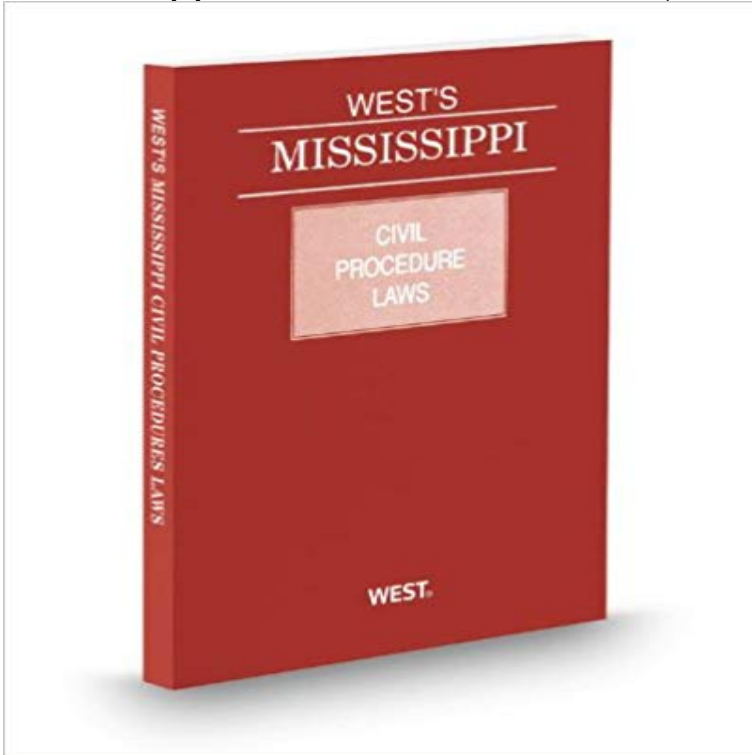


Mississippi Civil Procedure Laws, 2013 ed.
