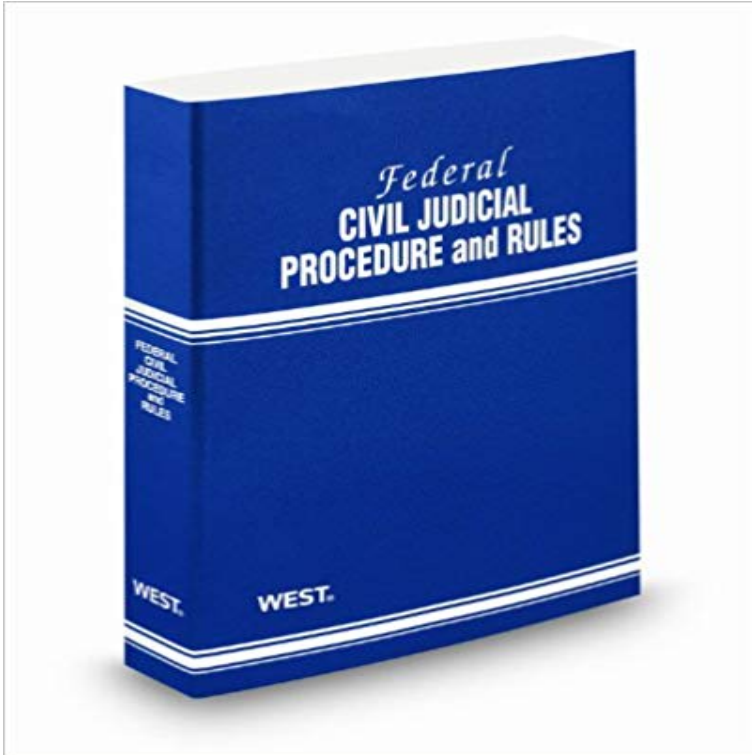


Federal Civil Judicial Procedure and Rules, 2012 ed.
