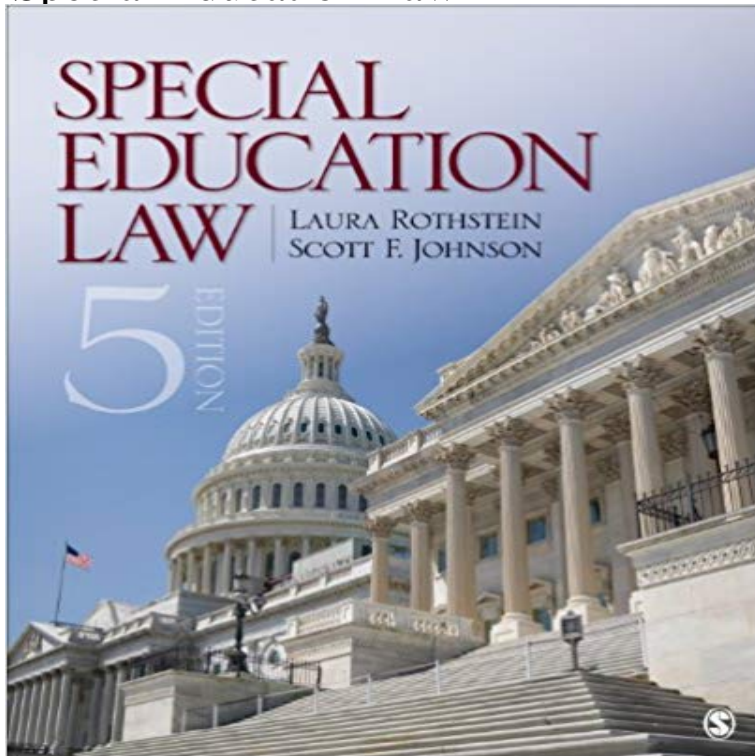


## Special Education Law
