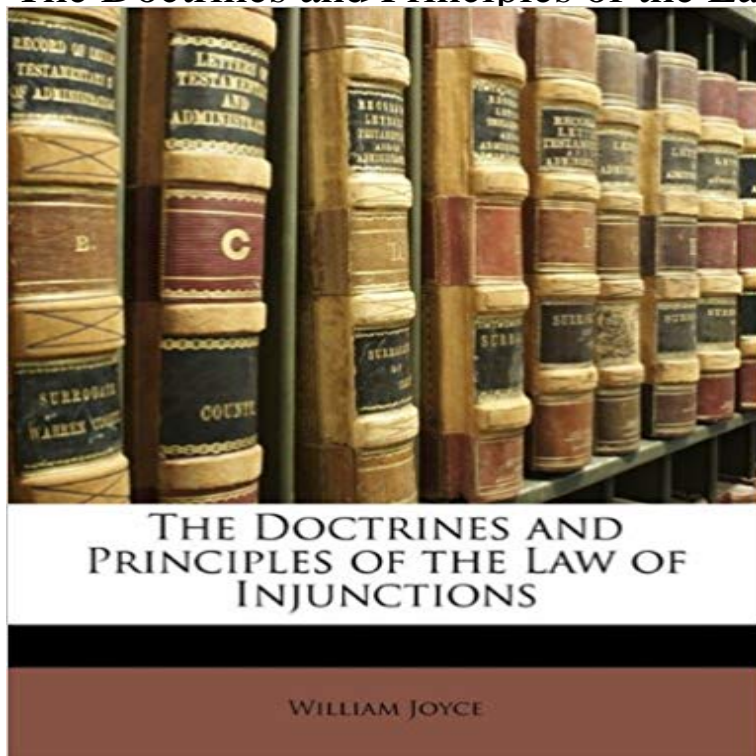


The Doctrines and Principles of the Law of Injunctions
