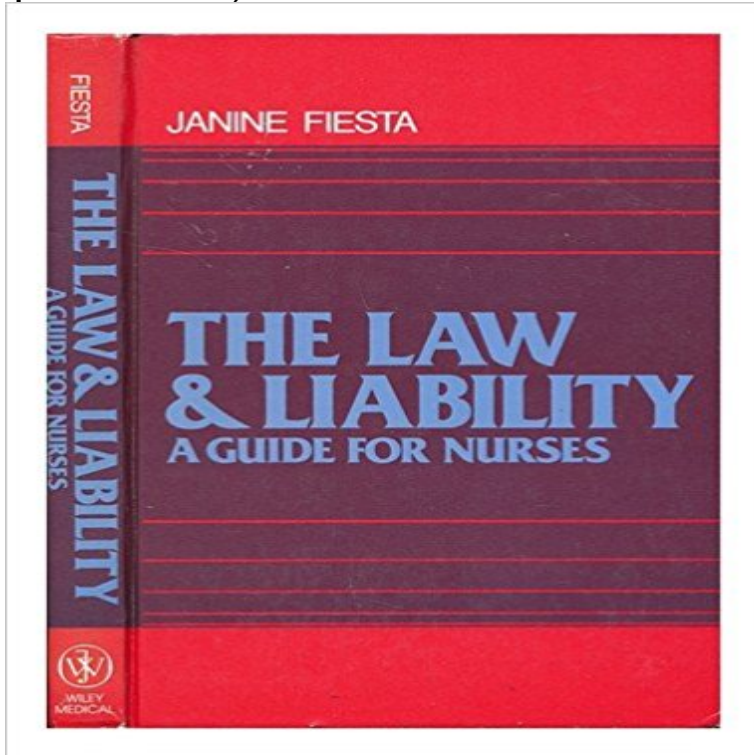


The Fiesta Law and Liability -: A Guide for Nurses (A Wiley medical publication)
