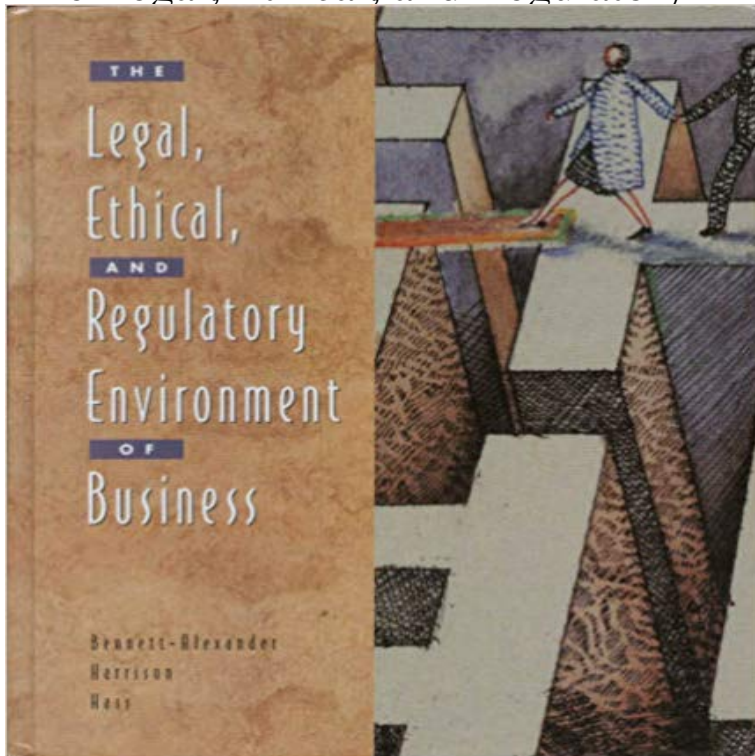


# The Legal, Ethical, and Regulatory Environment of Business
