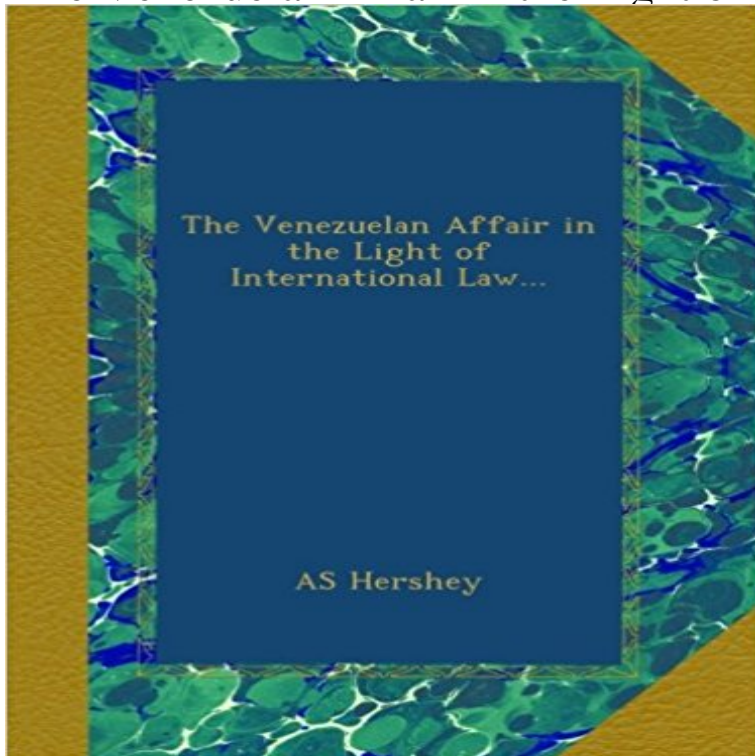


## The Venezuelan Affair in the Light of International Law...
